



# Coordination of the collection and synthesis of information on the NDS and SDG indicators

**Mustafo Tolibov Agency for Statistics under the President of the Republic of Tajikistan**

- ❑ At present, assessing the statistical potential of the Republic of Tajikistan for monitoring indicators of global SDG indicators is one of the priority tasks of statistical agencies. The Agency for Statistics is considered the main source of data, which collects information from its sources, as well as from other administrative sources, which are managed by ministries and departments.
- ❑ The main body of data, primarily quantitative (disaggregated by sex, age, ..), will be provided by the Agency for Statistics under the President of the Republic of Tajikistan (based on the developed specific reporting forms for relevant state and non-governmental organizations), as well as other ministries and departments ( in their respective areas of activity), which are fully responsible for the accuracy of the data collected.

- State statistical observations on socio-demographic issues
- Continuous monitoring of small and medium-sized businesses
- Population and Housing Census
- Sample Household Budget Survey
- Labor Force Survey
- Medical - demographic research;
- Administrative data (ministries and departments)

- An assessment of the potential for determining global SDG indicators for Tajikistan was carried out for all 232 SDG indicators agreed at the 48th session of the UN Statistical Commission with the exception of 30 indicators that are not applicable to Tajikistan (202 indicators).

In December 2017 ASPRT, with the technical support of UNDP, developed and approved a Roadmap for the implementation of the Action Plan for improving the National Statistics System of the Republic of Tajikistan for the period 2018-2020, the main purpose of which is to develop and improve the M&E of the NDS-2030 based on the SDGs, inventory the SDG indicators, identify priority tasks, as well as the development of a work plan for monitoring the SDG indicators, establishing cooperation with representatives of various authorities to achieve a monitor Inga SDG indicators.

To perform this work, data were collected on I-level indicators.

For the period of work on the report, 83 indicators were at the first level.

Only 71 indicators provided data.

Currently, work on nationalizing the SDGs is still ongoing. An assessment was made of the completeness of statistical indicators in the context of their availability not only in general, but also at a disaggregated level.

Administrative data sources represent an important potential for monitoring the SDGs, whose share in the total number of indicators is about 60%. Administrative sources are data annually produced by such ministries as the Ministries of Labor, Migration and Employment, the Ministry of Education and Science, the Ministry of Finance, the Ministry of Agriculture, the Ministry of Culture, the Ministry of Energy and Water Economy, the Ministry of Health and Social Welfare, the Ministry of the Interior and other departments.



**An analysis of data accessibility by oblast and stakeholder indicates that 161 SDG indicators are at the disposal of data holders or those institutions that are responsible for monitoring and evaluating the SDGs. Therefore, it is necessary to lead to a separation of tasks and efficient use of resources in the implementation and monitoring of the SDGs.**

**In all existing SDG indicators relevant to the Republic of Tajikistan, the leading producer of indicators is the Statistics Agency, which is responsible for the production of 46 indicators, of which 19 are in the economic field, 19 in the social sphere, 5 in the energy field and 3 in the field of rights and management.**
